L.A.A. Medical Libraries Section. Annual General Meeting. Brisbane,
28th August, 1984.

The Annual General Meeting of the Section was held during the NZ/LAA Biennial Conference in Brisbane. Some of the matters raised at the meeting are reported in detail elsewhere in this Newsletter. Among other items of interest were:

Accreditation Guide

The N.S.W. Group informed the meeting that a new edition of the Accreditation Guide is being prepared by the Australian Council of Hospital Standards. The National Committee has undertaken to contact the Council, and will take appropriate action if a revision of the Hospital Library entry is required.

Peer Review

The relevance of peer review and evaluation of library services was mentioned. It was generally agreed that these issues would be of future importance to our profession.

5th International Congress on Medical Librarianship (5ICML), Tokyo,
30th September - 4th October, 1985.

Theme: Medical Libraries - One World
Resources, Cooperation, Services

Planning for 5ICML is being reported in a series of Bulletins. A tentative programme of theme speeches alternating with concurrent sessions has been prepared. The first day will be devoted to a selection of continuing education courses provided by the Medical Library Association (U.S.), and to a tour of the Japan Information Center of Science and Technology.

Papers for presentation were to be selected by September 1984, and abstracts will be ready for distribution by 31st March, 1985.

Conference organizers are expecting about 15-20 participants from Australia and New Zealand. The L.A.A.- M.L.S. National Executive is making enquiries with airlines about package deals for group travel to Japan. For a group of 10 or more people, the return fare would be about \$1000. It would help the Committee if the approximate number of travellers were known. PUBLICATIONS

Bibliography of Australian Medicine and Health Services

This bibliography is a joint project of the Commonwealth Department of Health and the Royal Australasian College of Physicians History of Medicine Library. It has been accepted as an Australian Bicentennial Project.

The editorial committee wishes to include all publications of medical and paramedical interest, published in or about Australia. It is intended to include government publications and items held in private collections. The first priority will be to cover the period 1900 to 1950, but ultimately, the bibliography will list works published between 1790 and 1950.

IFLA World List of Biological and Medical Sciences Libraries

This will be the first such list since the Directory of Medical Libraries outside the United States and Canada was published in 1963. Its scope includes collections in biological sciences, veterinary science, pharmacy; dentistry and allied health, as well as medicine. It will also list equivalent national and regional directories, and associations of biological and medical sciences librarians.

The L.A.A. Medical Libraries Section was asked to provide details of 25 major resource libraries of Australia for inclusion. After consultation with State Sectional Groups, the libraries nominated as Australia's entries are:

NEWS FROM THE STATES

Items in this section have been compiled mainly from the minutes of State meetings. It will help the National Executive to ensure coordination and communication between State Groups if State secretaries continue to send copies of all minutes and local newsletters to the National secretary.

New South Wales

Nursing librarians are preparing for the move of nursing education to the Colleges of Advanced Education. A meeting between the present N.S.W. College of Nursing librarian, and C.A.E. librarians has produced an agreement to cooperate with acquisitions, and plans for a further meeting.

A sub-committee has been formed to examine hospital libraries' computing requirements.

The Group has drawn up a letter to be sent to new Section members. It is similar to a letter distributed by the Special Libraries Section.

Queensland

The Queensland Group has been busy this year organizing functions for the Medical Libraries Section members attending the NZ/LAA Conference. Activities of particular concern were the annual general meeting, a session

on career paths for medical librarians, and hospitality for interstate visitors.

At meetings during the year, the Group has been interested in standards for hospital libraries, and online searching using alternatives to MEDLINE.

South Australia

South Australian medical librarians have formed GRATISSA, a cooperative for free exchange of inter-library loans. Its aims include:

- the production and maintenance of a union list of periodicals of participants;
- provision of free inter-library loan photocopies between participants;
- reduction of dependence on the collections of larger institutions;
- cooperation at group level with similar groups, eg. GRATIS in N.S.W.

Membership is available to all South Australian medical and health sciences libraries. Member libraries are ranked according to the number of current periodical subscriptions.

The successful operation of the scheme will depend largely on the provision of an accurate union list, and the cooperation of member libraries in following the borrowing rules. Loan requests should be directed to the smallest library capable of satisfying them, and requests to larger libraries restricted to materials uniquely held by them.

A feasibility study is in progress to determine whether a separate major medical library should be established in South Australia. The South Australian Libraries Advisory Committee (SALAC) has been convened to enquire into state health library services, and report to government. An initial proposal was that a Joint-Medical Library should be established, based on major existing medical collections, eg. those of the University of Adelaide (Barr-Smith) Library and the South Australian Institute of Technology Library.

The Medical Libraries Section (S.A. Group) has made a submission to SALAC and is now awaiting the outcome of the study.

Victoria

The Victorian Group has compiled a set of Draft Minimum Standards for Victorian Hospital Libraries. Copies of the document have been sent to the L.A.A. Board of Education, and to the Committee to Monitor Library Standards. Further ratification of the standards, and their distribution to Victorian hospital libraries will depend on their acceptance by the L.A.A.

A Working Party has been convened to consolidate views on problems experienced in hospital libraries because of the Copyright Act.

A combined meeting with the Public Libraries Section on the topic of medical information for the general public was well attended by members of both sections. Discussion highlighted the need for continued cooperation between the types of libraries.

The Publications Working Party has produced a prototype List of Books and Journals for Small Hospital Libraries. It has been very well received, so it appears that a market will exist for a more formal publication, with contents updated where appropriate.
