Discussion about the role of Sections and Sectional Groups in the LAA (refer to Newsletter #3) has raised a few points: Sectional Groups (i.e., us) should continue to be funded by state branch councils. Lack of representation on LAA general council is a difficulty. There needs to be a path of communication between Sections (at the national level) and Sectional Groups (us).

VIBRA has also noted with concern cuts to the budgets of municipal libraries in Victoria. This is bound to have repercussions for other libraries in the state. Finally, the CSIRO's plans to cease publication of the Australian Science Index have been noted with some dismay.

Perth conference

Victoria was well represented at the 5th biennial conference of Australian medical librarians in Perth in September. An informal survey of attendees reveals that the event was extremely well organised, the speakers were stimulating, and there were lots of opportunities for constructive socialising.

The five sessions of the conference covered cooperation, getting information to the customer, medicine and the media, health information networking, and library management. Keynote speakers were Joanne Gard Marshall from the Palliative Care Foundation in Toronto, speaking about palliative care information and clinical librarianship; Dr Martin Cummings, just retired as the Director of the US National Library of Medicine, on the subject of American medical librarianship and in particular the politics of Index Medicus; Dr James H. Leavesly, a GP of ABC radio fame, discussing medicine and the media; and Dr Pat Layzell Ward, Head of the Department of Library and Information Studies at WAIT, talking about library management.

For those interested in hearing more about the proceedings, our group has ordered a complete set of conference tapes. These will shortly be available for loan from our Secretary, Aina Zalitis.

What's in a name?

For the record, the national annual general meeting held during the Perth conference took a vote on what we should call ourselves. We are now officially the <u>Medical Libraries</u> Section of the LAA.

Draft standards for hospital libraries

Draft standards produced by our working party were taken to the Perth conference for comment. Some interest was shown, and issues which have been raised so far include - whether our standards should be separate from or an appendix to those of special libraries; whether volunteers should be mentioned in them or not; how their definition of regional library services applies throughout Australia. Feedback from colleagues will be sought at our AGM on 25 November; please get hold of a copy of the draft standards, read them, and let's hear what you think. VAHPA, the union covering hospital librarians, has considered the status of library technicians in hospital libraries. Since they are non-professionals, VAHPA does not cover them, but they are eligible to join the Hospital Employees' Federation. Furthermore, hospital libraries considering staffing should bear in mind that the grading according to the medical librarians' award is affected by whether or not you supervise trained librarians; the supervison of library technicians is not covered. Science Citation Index

ISI, publishers of the Science Citation Index, have announced plans to publish an abridged edition of SCI. Whereas SCI covers over 3000 journals, both American and international, the abridged edition will index about 550, in citation, author and subject indexes similar to those found in SCI. The abridged edition is intended for smaller libraries, and will begin publication with an annual cumulation for 1983 available at the end of the year, and monthly publication from January 1984. Birth of ALIRF

The establishment of an Australian Library and Information Research Foundation has been approved in principle by the LAA general council. Australia presently has no equivalent to the American Council on Library Resources or the British Library Research and Development Department, to raise funds from the public and private sectors for research into Australian conditions, and to encourage and coordinate such research, especially among practising librarians. The proposed foundation would be a non-profit organisation, set up as a limited liability company under the LAA's control. It is possible that ALIRF could be in operation by 1985. The LAA is looking for comment, and for people who might like to be involved in the establishment of this foundation. What research needs to be done in Australian medical librarianship? Patient education

A draft statement on patient education, produced by the Hospital Library Service Committee, has been published in the August 1983 newsletter of the NZLA Health Libraries Section. It distinguishes between providing health related information and giving patient education, and the respective roles of librarians and other health professionals. It outlines several ways in which librarians and their professional organisations should promote and assist in the provision of materials to support these activities. It concludes that, "If the community is to be properly served in this area, librarians and health professionals need to work together on this with trust and sensitivity."
