Cherryl Schauder, a lecturer from the RMIT Department of Information Services was the guest speaker for the meeting at the Brownless Medical Library.

"Cataloguing with AACR2 to second level of description" might sound a rather dull topic. Cherryl's talk, however, was both informative and interesting, not only for newcomers to cataloguing but for experienced librarians who may have lacked time to study the finer points of the change from AACR1 to AACR2. Cherryl covered the layout of AACR2, the definition of corporate body, the choice of access points and the determination of main entry.

Later in the evening, Kathy Hutton of the Royal Children's Hospital spoke about the various options in our claim for professional rates and career structure. There was opportunity for discussion about grade definitions and allowances.

It was good to meet in such an interesting setting and we are grateful to Joan Martin for providing the venue.

#### UNION NEWS

The hearing of our claim for professional rates and career structure is awaiting the imminent decision on the nurses' claim. There has been agreement with the Department of Labour that allied health professionals should receive rates comparable to other health professionals, and that our group has an 'arguable claim'.

The Union's Steering Committee has proposed the following grade definitions:

Librarian Grade 1: working under the direction of a senior librarian.

Librarian Grade 2: in charge of a library or in charge of specific services or systems e.g. automated library systems.

Librarian Grade 3: in charge of professional staff.

Allowances are proposed for sole positions, managing multicampus or regional library systems, and higher qualifications in librarianship, computer science, and management.

# RESOURCES FOR NURSING EDUCATION

In May 1986 a Nursing Education Library Facilities Sub-Committee was formed at the request of the Inter-Departmental Steering Committee for the Transfer of Nursing Education from Hospital to Tertiary Sector Programmes. The sub-committee comprised:

June Buckenham: Senior Lecturer, Lincoln Institute School of Nursing
Sandra Russell: Representative for LAA Medical Library Section (vic.)
Catherine Pivec: Representative for Association of Librarians in
Colleges of Advanced Education

The purpose and function of the sub-committee was to make recommendations regarding:

- (a) Appropriate library resources for Colleges of Advanced Education where nursing courses are conducted;
- (b) The level and distribution of funding for these resources;
- (c) The impact that the transfer of nurse education may have on existing hospital library facilities.

#### The sub-committee recommended:

- 1) That there should be a comprehensive collection of books, journals and other media to support the college nursing programme in both depth and breadth. For example, in addition to recommended texts, it is desirable that further resources be available to foster independent studies.
- 2) That within this collection there be adequate provision of materials to support faculty members in their teaching, research and professional development activities.
- 3) That funding authorities be advised of the fact that hospital libraries will need to maintain strong nursing collections. These resources will be required to meet the increasingly sophisticated information needs of hospital nursing staff, and will accommodate the learning needs of college students on clinical placement.
- 4) That Resource lists for nursing collections be available for use as a tool for selection of appropriate materials for nursing library collections in colleges and universities.

  And furthermore, that college librarians be provided with a copy of the paper:

  Leith, Jean: Is there a core collection? Types of coverage, priorities. Paper presented at the Seminar on the Transfer of Nursing Education from Hospitals to Colleges: the Implications for Libraries. Frankston Campus, Chisholm Institute of Technology, 24 Oct. 1985.

# RESOURCES FOR NURSING EDUCATION (cont.)

The Committee discussed responses to the questions on library usage by College nursing students. It was agreed by many libraries that a problem exists. College students make additional demands on library resources, staff time, and library facilities.

The committee will write to all relevant colleges, associations and government bodies. It also recommends that each library take up the issue with their Director of Nursing so that the matter can be raised with colleges at the time of contract renewal.
